

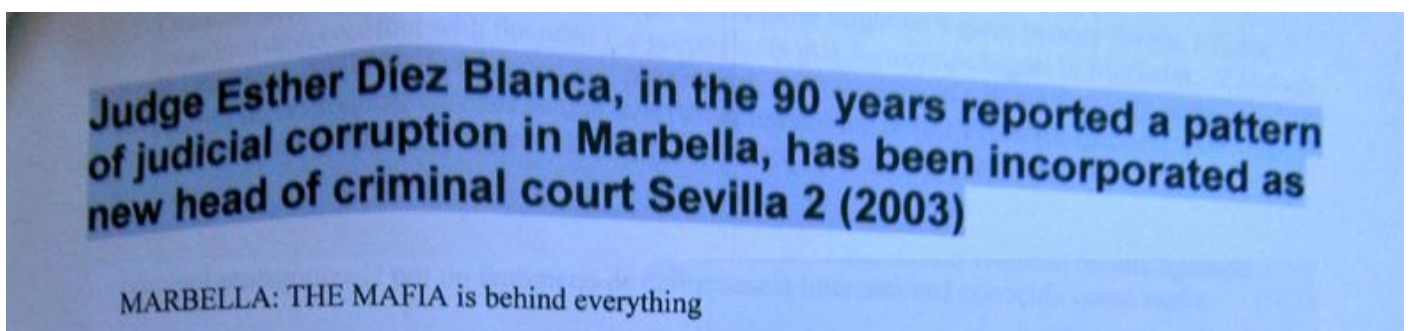
Another odd occurrence is that there are now two court number 4 in Marbella. When I first came back to Spain I would go to court number 4 at this building on the left below. After a year or two I became friends with a functionary there called Luis. He thought it was all wrong what was going on in my case, and said he would no longer put up with it, he started phoning everyone, and they moved the case back to the old court and changed the judge from the one that extradited us, to another judge at this building on the right, where corruption seems endemic. This we believe they did because the judge given the case and the fiscal did not want to touch it in any way.



I went in to the building on the right above after 4 years of waiting and stood in the middle of the top floor, telling everyone they were going to prison. It caused a scene and the Guardia were called as I refused to stop. Then Luis who I knew from the first court turned up, he was the new functionary in court number two now at the original place I was in court 25 years earlier. They could of moved him there because he would not put up with what was going on. Luis got a translator and took me into court number two where all the staff in the building gathered to hear what I was saying. I explained to the whole court what was going on.

The next time I went there on the bus, two Spanish undercover cops got on the bus with me and sat behind me and told me that it was all being handled by Madrid and that it was nothing to do with Marbella and they did not want to be involved in the case.

I decided to file a case with the Poder Judicial, who eventually took the case off Marbella and sent it to the Malaga court. Now at this point I have had four Judges and four Fiscals all who wont touch the case because it's so corrupt.



Before I came back to Spain, I looked up the judge Dona Blanca and found this out. I want to go to the press and get this judge dismissed from the justice system. We should bring criminal charges as would of happened at the TSJA, and should of happened 25 years ago, and sue her and her husband for damages.

Here is some further information about how the judge accused the Poder Judicial of being a Judicial Mafia and as a result her TSJA case on which she was convicted, was overturned and she was set free and reinstated so they did not all go to prison. It's a total disgrace and I demand to talk openly with the Spanish national media about it.

Solicita la realización de un juicio público

La jueza de Marbella, Blanca Esther Díez se acogió al derecho constitucional de no declarar a puerta cerrada ante el Tribunal Superior de Justicia de Andalucía y pide un juicio público. Está acusada de revelación de secretos y prevaricación.

La jueza de Marbella (Málaga), Blanca Esther Díez, acusada de los delitos de revelación de secreto y prevaricación, se acogió ayer a su derecho constitucional de no declarar ante el Tribunal Superior de Justicia de Andalucía (TSJA). "Me he acogido al derecho de no declarar a puerta cerrada y hacerlo en juicio público", dijo la jueza a los informadores tras recoger la copia de las preguntas que le habían formulado el magistrado de la Sala de lo Civil y de lo Penal del TSJA de Granada, Emilio León Sola, el fiscal y el representante de la acusación particular.

Blanca Díez explicó que le han formulado una veintena de preguntas sobre la querrela presentada contra ella por el ex-oficial de los juzgados de Marbella, Juan Ramírez, y sobre la evolución de las diligencias abiertas sobre este caso.

Se mostró "escéptica" respecto a la investigación abierta por el Consejo General del Poder Judicial (CGPJ) sobre la presunta existencia de una "mafia judicial" de Marbella porque, en su opinión, "se hace con lentitud y con desgana".

"Mafia judicial"

Manifestó también su impresión de que se le investiga más a ella que a la presunta "mafia judicial", opinó que se ha producido un "cierto cambio de criterio" en el TSJA que "antes era muy restrictivo en torno a la investigación a jueces" y ahora actúa contra ella "con criterios más amplios" y dijo esperar que todo se investigue con rigor y hasta sus últimas consecuen-

cias". "He abierto una brecha en lo que se supone que deberíamos hacer los jueces, pero el ciudadano espera mucho de nosotros", dijo la jueza, quien insistió en que "una cosa es que un juez se equivoque y otra, que sea un corrupto".

La jueza aprovechó su comparecencia ante los periodistas para agradecer el apoyo que le han demostrado los vecinos de Marbella, "que están muy sensibilizados" y que hizo extensivo también a todas las personas que la apoyan "en toda España".

Señaló que sabe lo que supone "tener miedo en Marbella a salir a la calle" y recordó que, según la legislación, está suspendida de sus funciones como jueza, pero que sigue realizando su trabajo porque así lo acordó

el Consejo General del Poder Judicial.

La jueza dijo a su vez, antes de declarar en el TSJA, que le "sorprendía" lo que le está pasando y que su capacidad de asombro "llega al límite porque hace cuatro años juré aquí un cargo que ahora puedo perder". Blanca Esther Díez presta declaración en la sala de lo Civil y lo Penal del Tribunal Superior de Justicia de Andalucía (TSJA) de Granada, por la querrela del exoficial de los juzgados marbellíes, Juan Ramírez. A su llegada al TSJA, la jueza de Marbella (Málaga) comentó a los periodistas que la están "persiguiendo" y señaló que se defiende a sí misma, su marido manifestó que ella "se mantiene fuerte, porque se crece ante las adversidades".

El Poder Judicial abre una investigación al hijo de su vicepresidente

El Consejo General del Poder Judicial ha decidido realizar una inspección del Juzgado de Vigilancia Penitenciaria número 1 de Barcelona, cuyo titular es el juez José Ramón Manzanares Codesal. Este magistrado es hijo del actual vicepresidente del Consejo General del Poder Judicial, José Luis Manzanares, cuyo nombre ha aparecido ligado a las investigaciones de la jueza de Marbella Blanca Ester Díez sobre una presunta trama de corrupción judicial.

El Juzgado de Vigilancia Penitenciaria número 1 de Barcelona, cuyo titular es José Ramón Manzanares Codesal, está siendo objeto de una investigación por parte de tres inspectores del Consejo General del Poder Judicial (CGPJ), que pretenden aclarar varias denuncias presentadas contra dicho juez por parte de abogados particulares, familiares de presos, el Colegio de Abogados de Barcelona y la Asociación Catalana de

Juristas Demócratas (ACJD). Se da la circunstancia de que José Ramón Manzanares Codesal es hijo de José Luis Manzanares Samaniego, actual vicepresidente del CGPJ, cuyo nombre aparece presuntamente ligado a algunos de los protagonistas de una trama de corrupción judicial en la Costa del Sol, cuyos pormenores han sido desvelados por TRIBUNA en las últimas semanas.

La investigación sobre este juez se decidió el pasado 27 de mayo en

la reunión de la Comisión Disciplinaria del CGPJ, que preside José Antonio Zarzalejos Martínez. En la misma, se tomó el acuerdo de practicar «una visita extraordinaria y urgente de inspección al Juzgado de Vigilancia Penitenciaria número 1 de Barcelona con el objeto de comprobar la realidad de los hechos que se denuncian».

El tono del documento en el que se solicita la investigación, que obra en poder de TRIBUNA, concede veinte días a los inspectores para que informen, entre otras cosas, «del número de solicitudes de permisos penitenciarios pendientes de tramitar» y «del número de peticiones de abogados de oficio pendientes de tramitar».

El juez Manzanares Codesal ha declinado confirmar a esta revista la existencia de esta investigación alegando que sólo hacía declaraciones «sobre sentencias en firme». Ahora, el CGPJ ha decidido finalmente tomar en consideración las denuncias contra el juez. Además, la actuación de Manzanares Codesal ha provocado malestar en la Generalitat, que ha interpuesto un conflicto de competencias.

Quejas. La Asociación Catalana de Juristas Demócratas había presentado contra el juez Manzanares Codesal una querrela criminal por un presunto delito de prevaricación. Según la citada querrela, desde el acceso del juez al Juzgado de Vigilancia Penitenciaria número 1 de Barcelona, con jurisdicción sobre la cárcel Modelo y la de la Roca, los presos de ambos centros penitenciarios vieron sustancialmente reducidos sus permisos de salida, aumentaron las sanciones y, además, el juez Manzanares se negó a recibir en alguna ocasión a los familiares de los presos.

En la queja presentada por el Colegio de Abogados de Barcelona ante el CGPJ se recuerda que en la última reunión mantenida por los jueces de vigilancia penitenciaria de toda España se instaba a que los abogados del turno de oficio atendieran a los presos. El único voto discrepante fue el de José Ramón Manzanares Codesal. No es de extrañar —se señala en el citado colegio— que «el número de peticiones de abogados de oficio pendientes de tramitar ronde en estos momentos las doscientas», ya que Manzanares Codesal no le ha concedido al Colegio de Abogados de Barcelona los permisos preceptivos.

La jueza Díez pedirá un examen psiquiátrico de Juan Ramírez

• Santamaría se ratifica en sus denuncias contra el presidente del TSJA en la trama de corrupción de Marbella

MARBELLA-GRANADA.— La jueza Blanca Díez ha decidido interponer una querrela contra Juan Ramírez Rodríguez «para pedir un examen psiquiátrico de este hombre, ya que sus manifestaciones son propias del delirio de una mente enferma». La titular del juzgado número cuatro de Marbella tomó esta decisión ayer tras conocer, a través de EL MUNDO, el contenido del escrito enviado al Consejo General de Poder Judicial y al Fiscal General del Estado por el hijo de Ramírez, el abogado Juan Carlos Ramírez Balbonte, en el cual se acusa a la jueza de ser ella, con otras personas, quien dirige la llamada «trama de corrupción judicial en Marbella».

En declaraciones a este diario, la magistrada opinó que «una reacción tan desproporcionada como la que evidenciará ese escrito no hace más que demostrar hasta qué punto es cierto lo que tengo denunciado y lo que todos sabemos en Marbella». Díez reiteró que tiene «el máximo interés en que todo se investigue». Las juezas no quieren hacer otros comentarios porrazonados sobre el texto de Ramírez «ya que no tengo interés en entrar en este tipo de polémicas, que sólo buscan confundir a la opinión pública y que sólo persiguen tapar la realidad de la situación que, insisto, debe ser investigada hasta el final».

Por su parte, el ginecólogo malagueño Germán Sáenz de Santamaría se ratificó en la mañana de ayer lunes en sus denuncias contra los jueces andaluces y contra su presidente, Manuel Rodríguez López, en las declaraciones que realizó ante el titular del Juzgado de Instrucción número 6 de Granada, Miguel Ángel del Arco, por un presunto delito de desacato.

Sáenz de Santamaría, que aseguró que «el poder judicial es hoy por hoy una institución impune», realizó la pasada semana unas polémicas declaraciones en las que comparó a los jueces de Andalucía con Herr Batasana e implicó al presidente del Tribunal Superior de Justicia de Andalucía en la trama de corrupción judicial imputada a la jueza Blanca Díez.

El fue Andalucía, Luis Portero, Jor de oficio las diligencias en contra del ginecólogo malagueño, considerando que las anteriores manifestaciones podrían ser constitutivas de un delito de desacato.

Germán Sáenz de Santamaría acusó a Granada en calidad de presidente de la Asociación para la Defensa del Estado de Derecho y para manifestarse en solidaridad con la jueza marbellí quien, el pasado martes, prestó declaración ante la sala de lo civil y lo penal del Tribunal Superior de Justicia de Andalucía como presunta autora de un delito de prevaricación y revelación de secretos.

■ GRANADA Sáenz de Santamaría implica al presidente del TSJA con la mafia de Marbella

El ginecólogo malagueño y coordinador de la Asociación de Defensa del Estado de Derecho, Germán Sáenz de Santamaría, denunció ayer la implicación del presidente del Tribunal Superior de Justicia de Andalucía (TSJA), Manuel Rodríguez López, en la "mafia judicial" de Marbella (Málaga). Sáenz de Santamaría, quien acudió al TSJA para apoyar a la jueza Blanca Esther Díez, que declaró ayer ante el alto tribunal andaluz, acusada de los delitos de revelación de secreto de sumario y prevaricación, dijo a los periodistas que "por acción u omisión el presidente del TSJA es cómplice de esta mafia".

Responsabilidad

Según este ginecólogo, cuando Rodríguez López ocupó la presidencia de la Audiencia de Málaga recibió "muchas denuncias contra jueces por prevaricación y no hizo nada".

"No puedo demostrar que lo haya hecho de mala fe, pero lo ha hecho y objetivamente es responsable" dijo Sáenz de Santamaría, quien señaló que precisamente Manuel Rodríguez preside la sala de lo Civil y de lo Penal, ante la que declara la jueza de Marbella. Según Sáenz de Santamaría, "presuntos delincuentes están juzgando a la única persona inocente de esta historia", por lo que la Asociación de Defensa del Estado de Derecho ha aconsejado a Blanca Díez que se niegue a declarar y solicite un jurado popular, "pues de lo contrario éste será el único proceso a un juez que puede prosperar en España en los últimos cien años".

El ginecólogo anunció también que su asociación ha recibido denuncias contra varios fiscales de la Audiencia de Málaga por "deudas de juego, pago con cheques sin fondos y préstamos", de las que se deduce que los fiscales

Title: Spain's female Wyatt Earp in the dock: Marbella's anti-corruption judge has made enemies on the Costa del Crime. Phil Davison reports

FOR Blanca Esther Diez, a 31-year-old judge from Marbella, tomorrow's will be her toughest case and the outcome is out of her hands. The judge will be in the dock, challenged by a system she has fought to prove is riddled with corruption.

Formally, she is charged with dereliction of duty and revealing details of a case. If found guilty, she would be the first judge condemned on such charges in Spain's modern history. That could mean two months in jail, suspension for three years and a fine of 100 million pesetas (nearly pounds 500,000). Her Marbella home has already been 'embargoed' - held as collateral - to cover the possible costs of the trial.

Effectively, someone is trying to run her out of town. When Judge Diez, from the northern Asturias region, then only 27, hit Marbella four years ago, it was as though a young female Wyatt Earp had blown in to clean up the town. Thousands of Marbellans have marched in her support and five leading citizens are approaching one month on hunger strike, demanding an end to judicial corruption.

'The Spanish Inquisition continues, quite literally,' said one of the hunger strikers, a retired businessman, Fernando Rosado, 62. 'Justice in Spain is the best money can buy. There must be some honourable judges but they are cowards. By being cowardly, they're protecting the corrupt.'

For once, when the British tabloid press refer to the Costa del Sol with their favoured Costa del Crime headlines, they are not wrong. British, Italian, Arab and other high-flying criminals, live and operate here in style, flaunting their wealth with large yachts at the nearby Puerto Banus marina. Judge Diez believes she has found out some of the reasons why.

She compiled dossiers that she said linked former judicial officials here with the Sicilian Santapaola Mafia clan. Her dossiers suggested illegal laundering of Italian Mafia money through the purchase of art works, antiques and, especially, property.

Based on investigation of past cases and judgements, as well as sworn statements from witnesses who wrote to her supporting her anti-corruption stand, Judge Diez's dossier centred on one of Marbella's most influential figures, a former judicial official called Juan Ramirez. Mr Ramirez's exact profession has never been clear, but he worked in the local courts and often acted as a legal adviser to accused persons.

Mr Ramirez, in his sixties and known to some business associates as 'el flaco' (Skinny), is also the father of one of Ms Diez's fellow Marbella judges, Pilar Ramirez, and of a local lawyer, Juan Carlos Ramirez. Judge Diez's lawyer, Luis Bertelli, contends that, under Spanish law, such family ties are illegal in a town of fewer than 10 judges. Marbella has seven judges, including Ms Diez. Mr Bertelli also says Mr Ramirez has acted as a lawyer illicitly since, according to Mr Bertelli, he has no qualifications.

Mr Ramirez has long been a friend of Carmen Proetta, 50, a resident of San Pedro de Alcantara, near Marbella, and the key witness in the 1988 SAS killing of three IRA terrorists. Ms Proetta has said she acted as an interpreter for Mr Ramirez in cases involving Britons.

Acting on witnesses' allegations, Judge Diez ordered Mr Ramirez's phone legally 'bugged' in January last year. She later ordered him jailed in 'preventive detention' pending trial, on suspicion of involvement in the fraudulent sale of a Marbella casino.

After two months inside, another judge - not his daughter - ordered Mr Ramirez freed without bail. Mr Ramirez made a formal complaint against Judge Diez, a move that automatically led to her suspension and tomorrow's trial. He accused her of dereliction of duty and of revealing details of his case. She denies both accusations, saying Mr Ramirez and corrupt colleagues are trying to get her off their patch.

According to Mr Bertelli, the phone tap revealed a close friendship between Mr Ramirez and Jose-Luis Manzanares, vice-president of Spain's General Council of Judicial Power, the legal watchdog body appointed by parliament.

That relationship has turned the judge's trial into an event of national importance.

McCARTHY Corporation, the technology and leisure investment vehicle, has teamed up with Cable & Wireless and ICL to create a £100m sales a year internet business.

The company, Virtual Internet Provider, will allow famous retailers and consumer product companies to offer their own internet services and substantially boost awareness of their own web sites.

Potential clients include United News & Media and Cyberus, the music direct sales company. One of the big four clearing banks is also said to be interested.

What the business did was allow the internet to spread worldwide at an incredible rate of take up. We placed CDs on the front cover of every IT magazine in the UK offering branded internet connectivity with people like Dixons, MI5, Nat West Bank and so on.

An established company could thereby use their branding to leverage their client bases to come online safely, and what I did, was got cable and wireless to provide the telecoms services up to £10m before any bills, and ICL to manage my computer platforms again with £10 million pounds of services without any bills, this was so there would be no stall in the roll out due to finances. We had all the money it needed before we started, and I did due diligence and proved it, and then they stole it from me and used this case to ring-fence me. My point here is that it's only the filthy mason scum that are stopping me becoming rich to protect themselves. I believe this means we should not underestimate the money I am due from these criminals as well as the Spanish Justice (laugh out loud) system.

What I want to say to the media and why I want to call a press conference in Madrid.

We have been unjustly treated by the Spanish justice system and we are filing a compensation claim. For 25 years i have been accused of a crime, that there was no evidence for, in fact there is clear 100% irrefutable evidence I was not there. I have never been charged, and i have been falsely imprisoned for years. I now wish to sue the Spanish Justice system and UK authorities for false imprisonment, damages, and the extradition.

At this point we don't believe anything the Spanish authorities say, and we are looking to expose the people and case nationally. I have never had chance to even speak to the court at any point since the extradition 7 years ago, despite asking too even with lawyers.

We need to arrange suitable publicity with the Spanish National press and TV, these are some of the points i wish to discuss with the Spanish media:

Spanish Press Release For Discussion:

I want to know how the Spanish justice system can destroy my life, breaking its own laws with its legal representatives committing crimes to falsely imprison me and then destroy my life? If it were not for the fact that I was a public figure in the Heavy Rock business they would of got away with setting me up!

When i was arrested and first appeared in Marbella court in front of Dona Blanca, she had a court functionary measure my feet, in open court, in front of everybody, she had all the carpets from the crime scene and there was footprints everywhere from the people that did the crime, i have size 40 or size 6 shoes, the people that committed the crime had much larger feet, she said in open court right then that i was not there and could not of been involved, i want anyone from that hearing to come forward including my interpreter!

I call for the police officer studying to be a lawyer who spoke English, from the Aresto Municipal Marbella from 25 years ago who told me that judge Dona Blanca Esther Diaz and her husband police inspector Jimanez who was the chief investigating officer for the Marbella International Crime Squad part of Interpol (a miscarriage of justice in itself that they were married), were planning to set me up for the crimes and he did not agree or like it. He should come forward and speak the truth of what he knows, and explain in his own words why he let me escape from the Aresto Municipl in Marbella because he said they were setting me up. I ask this person to come forward for justice sake and expose this corrupt judge and her bent police husband, Spain deserves better.

I call for the Marbella Court number 4 functionary who was also imprisoned by the judge Dona Blanca to come forward and talk of how he knew the documents in my case were falsified by Dona Blanca and Inspector Jimanez, and what else does he know about the goings on regarding this corrupt Judge and Senior Police official!

How can Dona Blanca be a Judge in Spain? When we have proof she is a criminal? Who is covering this up? I call for her immediate dismissal from the justice system and her assets seized as compensation for what her and her husband have done to me. I would also call for all the justice system to be scrapped as not fit for purpose.

I call on the NCIS (National Criminal Intellegence Service)/MI6 Agent and Norwegion Inteligence Agent who met me upon my release to come forward and explain where they got the information from that the person murdered was in fact a Norwegian Drug Trafficker, who was buying cocaine on the costa del sol and selling it through his night clubs in Norway.

I openly accuse the British Drug Mafia, the same British Drug Mafia that the British government don't want to admit exists, the same British Drug Mafia that uses Freemason lodges in Spain to coordinate and run drugs gangs. I demand a full review of funding for the justice system and security services funding that has clearly been abused in my case and for corrupt reasons!

I wish to make denuncias against the lawyers we had appointed by the court and any officials involved from the start to now in the entire paper chain.

I wish to make denuncias about the British Drug Mafia that kidnapped my wife and I in Estapona and help us at gunpoint while they stole our computer so they knew what information we had on them and the case, and they have been using this to corrupt the process. Plus we want the judge arrested and charged Dona Blanca and we want her assets seized.
