

## **Request & Information To The Spanish Court:**

**20/06/2016**

On the 15<sup>th</sup> June 2016 at Torrox court while signing for this case Sumario 1/1992 de Juzgado Numero 4 de Marbella I received two documents from the Audencia Provincial de Malaga Seccion Primera. It is my understanding that any official document issued by a judge has to have a sequential number on it to avoid corruption, the document I have has no number making it not official, is this correct? Every document I have from a court has this number! I want the official document with the number on it from the court. As it stands the document could be fake!?

I don't fully understand what is written on the document, but I know for sure that some parts are a total fabrication, for example, it says all the people that were visiting Tor were musical orientated this is completely wrong, there were a few people meeting him for that reason, most were meeting him over drugs deals as he was buying cocaine on the costa del sol and selling it through his nightclub in Norway, I was told this by MI6 and Norwegian security services.

I can respond further once I know what the document says in English.

This document is in response to those documents:

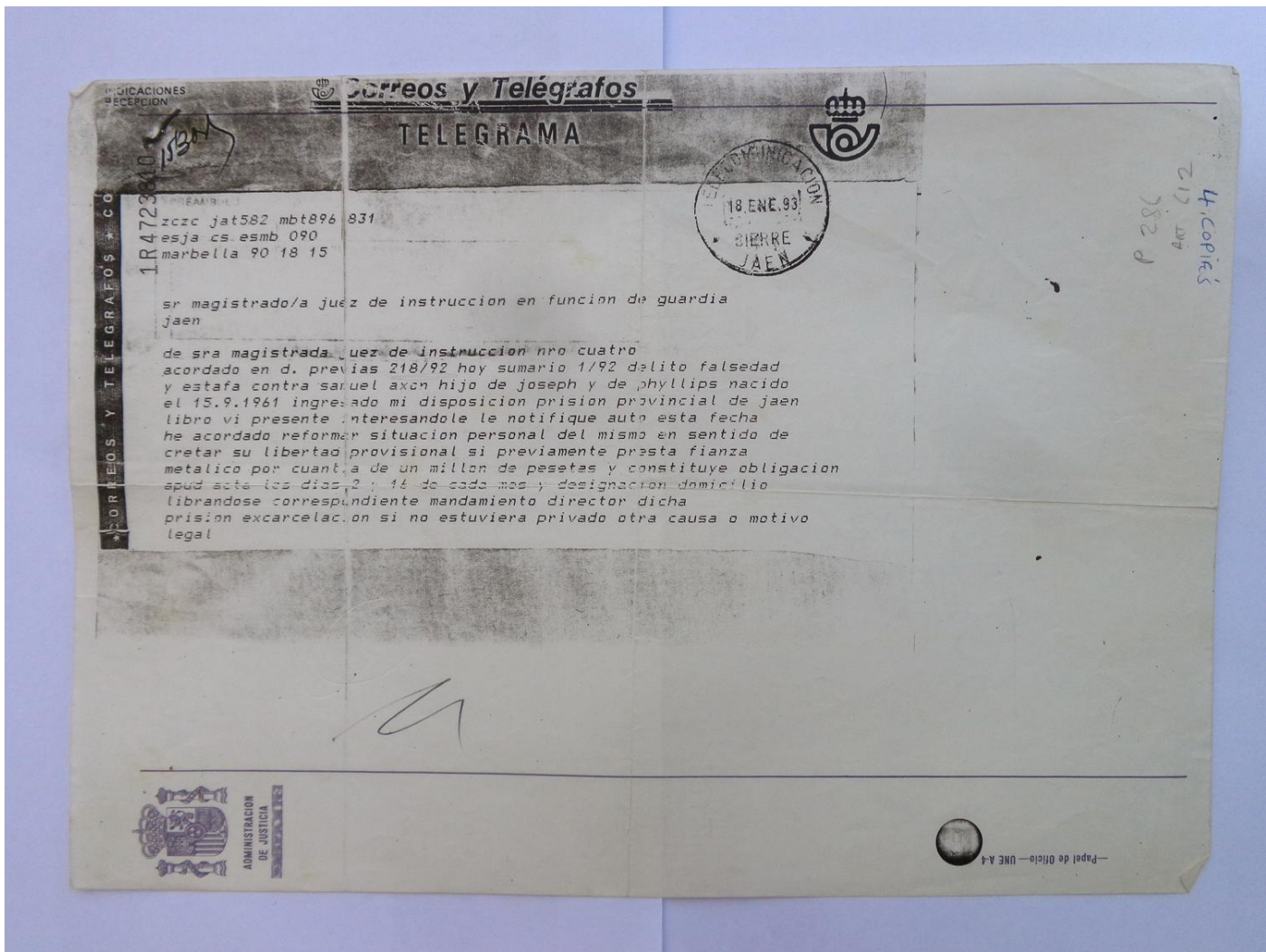
I would like to arrange a meeting to talk with the Judge for this case as soon as possible. I don't have a lawyer or translator and I have no money.

### **1/ Bail Conditions:**

I would like to have my bail conditions dropped, and have my passport returned and my bail money 6000 Euros refunded to me, based on the evidence and information to the court.

Original First Bale Document:

This was bale with finance. At this point I was suspected of Estafa, which after consultation with the fiscal, the judge and fiscal both agreed that it was under duress and I had to face no charges. I was a protected witness.



**Second Bale Document:**

This was bale with no finance. After I was given the first bale document a member of the British Drug Mafia wrote a letter to the judge saying I had told him I was involved. The judge Dona Blanca told me this was the only reason I was not released earlier, I later found out that the judge was suspended for corruption/negligence charges and could not deal with my case as she was facing criminal charges herself. After investigation the judge found out who he was connected to and knew the British Drug Mafia committed the crime already and why.

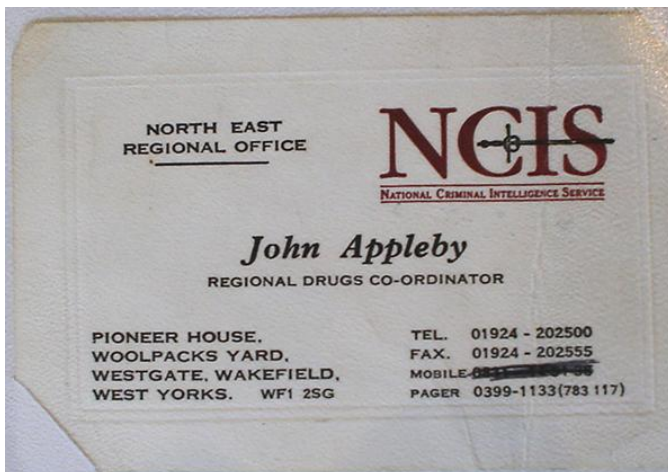

During my false imprisonment and after my release I was invited to work with MI6 against the British Drug Mafia, I was sent a telegram to meet with agents, I did this and worked with them for 3 years.



I found out that the British Drug Mafia was using Masons Lodges to do there trade. At that time and now some Masons who run lodges are run by the British Drug Mafia. After an altercation with the leader of the British Drug Mafia I was told by Toby Childs (Liaison Officer at the British Embassy Madrid, MI6) and Paul Stoodley (Senior Liaison Officer at the British Embassy Madrid, MI6) to go to the UK for my safety. My whereabouts in the UK was known at all times by the police, and we can prove this.

Upon my return to the UK, I was approached by NCIS (National Criminal Intelligence Service). I was given protection and a number to call armed officers to my location should i need it. This is the card of the protection officer that met with me upon my return to the UK.



I was invited to Scotland yard to attend an internet conference on how to capture paedophiles, only ISP (internet service providers) owners were invited and attended, i was invited by Michael Hoskins head of the Internet crimes unit at Scotland yard who approached me at Earls Court internet show, the first one where my company Merlin Internet had its own stand. He came to invite me specifically to try and help bring paedophiles under control on the internet as i was a leading expert in internet, this was 1996. So any suggestion that the police did not know my whereabouts is an utter fabrication.

I have many letters of correspondence with the UK police throughout my entire time in the UK. They lied to the Spanish or the Spanish never requested the EAW (European Arrest Warrant) in

the first place, this we need to get to the bottom of. This case in Spain was brought up and used to stop a lawsuit in the UK from going forward against MI5 and UK Masons.

My son had a police protection officer assigned all through school, so it's ludicrous to say they did not know our whereabouts. I have complained to the police commissioner and others and have all the letters.

I need to be able to go to the UK, and other countries, so I can try to re start my career.

## **2/ Miscarriage of Justice:**

I want the case dismissed as a miscarriage of justice, not wait one year more until statutory it runs out of time, and we don't want it archived, it's a clear miscarriage of justice and I want my life back so I can play music again, and so i can sue everyone involved and get some justice.

We want to file a miscarriage of justice denuncia, copy to go to el Poder Judicial and Tribunal Superior de Justicia de Andalucía (TSJA), Junta de Andalucía and the Spanish Justice Minister and Head of state with other support letters. We want the case ended, not allowed to run out.

### **Reasons:**

I was ruled out of the crime in the first 5 minutes in court 25 years ago, I have very small feet and they were measured and the people that committed the crime all had large feet. I was imprisoned for 30 months illegally, I have had this hanging over me, without charge for 24 years and had my life destroyed ruining my music career. I was originally arrested along with 12 others in relation to the murder of a Norwegian man, at that time i was about to record a solo album in his 24 track recording studio that was in his house. I only knew him as a guy who had a recording studio. The guys that introduced me to him were responsible for his death, we know this for a fact but no charges have ever been brought against them, i was a witness to the case only. At the first court hearing in court number 4 Marbella they established i was not there at the crime scene using forensic evidence, as they had the carpets from the crime and my footprints were not there, the magistrate said in court i was not there and was not responsible, we want the people who were in court that day and the court transcripts published as part of the case.

I was told by the Judge that there would be no charges against me for anything upon my release, I was a witness against Alan Wilcock and his gang of drug dealers, and was held in protection in prison for that reason, we have all the documents that prove this.

The Instruction Judge Dona Blanca Diaz was married to the lead investigator Inspector Jimenez in my case, this led to criminal acts and corruption and is a miscarriage of justice, we have court documents that prove this.

The Instruction judge got me a lawyer at the end after 2 years in prison, the lawyer she got was the same lawyer that represented the person who committed the crimes, and his business interests. I only found that out after i was out of prison.

This is clear corruption and another miscarriage of justice. The first lawyer we had appointed was Manuel Linares de Oliver, that was after 2 years in prison, the judge under pressure from the justice ministry brought him to the prison I was held in, he spoke English, and they explained to me that I had been held because she, the Judge Dona Blanca, had been arrested and that her husband Inspector Jimenez (head of the international crime squad and lead investigator, in our eyes a miscarriage of justice in itself) had signed court documents in her absence committing an imprison able offence and falsely imprisoning me. He did this because I had been treated very poorly while in the Aresto Munciple in Marbella when first arrested and I broke out and booked

into a hotel close by, I left a letter to the judge explaining why, it led to everyone in the Aresto Munciple being sacked and closed. So it was out of revenge they imprisoned me not because of this case.

There was a police officer on duty that was studying to be a lawyer he spoke English who told me they were trying to set me up on the charges and he did not agree with it, so I left. When I got out of prison years later I found out that Linares was the lawyer of the person that committed the Murder and bought properties for him, another miscarriage of justice perpetrated by the judge. There is a lot more to this part of events and I would need to go through it in detail with the court.

A Police officer studying to be a lawyer told me Inspector Jimenez was setting me up and he did not agree with it, we need to get this man to make a statement before the court.

The functionary from court number 4 Marbella was sent to prison and while in prison he came and spoke to me about what went on and told me i had been falsely imprisoned and had false imprisonment papers, i started to check this and found it was true, i still have them. We need to get this man to make a statement before the court.

I want to know exactly what went on with the judge and her husband, before during and after they falsely imprisoned me, i wish to bring a denuncia of false imprisonment, based on the evidence and criminal charges of falsifying court documents.

## **6/ Denuncias I Intend To Make:**

**We wish to make several Denuncias and bring criminal charges and lawsuits:**

**Prior to lodging these denuncias, we request an initial meeting to discuss the denuncias and time after the meeting to gather more information to present the case.**

The Spanish court should be aware that we intend to sue the UK and Spanish authorities, as per the information on the [www.gary-owens.com](http://www.gary-owens.com) website.

We believe the Spanish court has been used and duped by the UK freemasons who appear to be controlling all the Drug trafficking in Spain (i have proof of this). They have used members of freemasons within the UK security services, to bring this case about because i intended to sue them in the UK, I have provided an evidential letter sent to a UK MP that shows why this case was dreamt up to steal my money and imprison me, please read Prime Minister letter 5-11-2015.doc.

We want a public enquiry to what has gone on in Spain, we will petition for this through the media, to expose the Judicial Mafia and the corruption that exists here in Andalucía, the UK and the EU in General.

### **a/ Police Perverting The Course of Justice Denuncia:**

Rosario Gomez Bravo Abogada, Maria Jose Cortes Castan Abogada, Spanish and British Police, Court Number 4 Marbella.

On the 21<sup>st</sup> of April 2015 we asked a local lawyer who spoke English to try to find out what was going on in a case concerning me for 24 years. I was extradited 6 years ago as a matter of urgency costing millions in costs to Spain and the UK, the case went all the way to the supreme court, they would not sit and hear it at the house of lords as I was accusing masons and they are many masons in the house of lords, and it would be televised and they did not want me accusing masons on television, my case was the first case ever filed at the supreme court in the UK.

At the first meeting Marie seemed to be efficient and good at her job. I was recommended to this lawyer by our landlord Manuel, a local business man and ex council member in Torrox.

I gave Marie three denuncias to translate on Tuesday 7<sup>th</sup> of April I was to get them back translated into Spanish three days later on Thursday, I heard nothing and decided to call into her office on the Monday to find out what was going on, I was brushed aside, saying she would call me back, she did not call. Several more days passed, and at a chance meeting with our landlord I decided to ask him about the lawyer as he had recommended her and it was an urgent situation for us.

I ask Manuel what is going on with this lawyer and explained to him some of our circumstances, that we were under threat and being harassed by some people. He called Marie for me and he spoke to her and then passed the phone to me, she gave me a day to go and see her 3 days away, she had done no work on the denuncias.

At the meeting she gave us a denuncia made out in Spanish we thought at the meeting we had all three denuncias, but there was only one (copy in English and Spanish attached). Marie was very different and seemed very evasive and did not want to help us, there was only one of the three documents translated. The two documents that were not translated were a denuncia for the Malaga Police that would also act as a hand out leaflet that outlined the harassment that was going on around us to give to local people so that someone could come forward and give us information. The other was a denuncia about a tracking implant that I believe has been put in my body, this is a well known system of control and involves tracking, using Microwaves its also able to talk inside a person's head and listen to what they say, the device can be used to do harm to the subject and this is happening to me, I have experienced load ringing noises in my head, puss spots have appeared all over my head, which I believe is a result of Microwave Radiation, there is also piercing pain and a low frequency noise thats disorientating, this is a weapon and can be used to kill people, I believe they are attempting to murder me to stop the truth coming out about what has been going on in our lives.

There was no reason why these documents were not translated and were not even mentioned when I left the office, I thought we had all three, but later found out there was only one. I was convinced that the police or some other party with an interest in this case had spoken to her, I was not sure at that time but it became clear later what was happening. I asked if she could also do some other work we needed doing, and said I would call back at the office on Tuesday 21<sup>st</sup> of April, this was to prepare the letters that were to go with the denuncias. We don't read Spanish so we have no idea if what is written is correct.

At the meeting on the 21<sup>st</sup> of April, we were met with the same cold reception at first, then as we started to explain to Maria what was going on and showed her documents, she started to change and became pro active. The Abogada phoned the Fiscals office in front of Jayne Owens and I, she found the name of the lawyer that was supposed to be representing us, and spoke to the functionary of the Fiscal who told her that the case was a mess and had been sent back as there was no evidence. The functionary actually told our lawyer that if we wait 18 months the case would be over and we can then claim compensation. This was a huge shock to us. The case is a complete fabrication from start to finish and no one wants to touch it. So far we have had 4 judges 4 courts and 4 fiscals, all have done nothing about our situation.

The Abagada at the same meeting filed a denuncia with the poder judicial against the Marbella court. This was done as one of the documents we had given her originally was a reply from the poder judicial that we had contacted by email, we did not understand what was in the poder judicial email so she filed a case for us, while she was filing the case it failed several times, she said it was not accepting my email, which made no sense I I have had the same email for 20 years. She eventually got it to go but with her email address on, so we have no idea if there is any response. She set an appointment for us with the lawyer we had been appointed in the case for the following day. She also got us contact details for a lawyer we were looking to engage to represent us in this case.

We had an appointment to see the court appointed lawyer for the 23<sup>rd</sup> April 2015. The Abogada said she knows nothing of the case and was very evasive and would not help us in any way. Prior to the meeting we were kept waiting for one hour, with what we believe was a police officer in the reception with us, I recognised her but could not place where from, the lawyer was in a meeting with a Spanish man for one hour, we believe that they were listening to us trying to find out what we were going to do re the case.

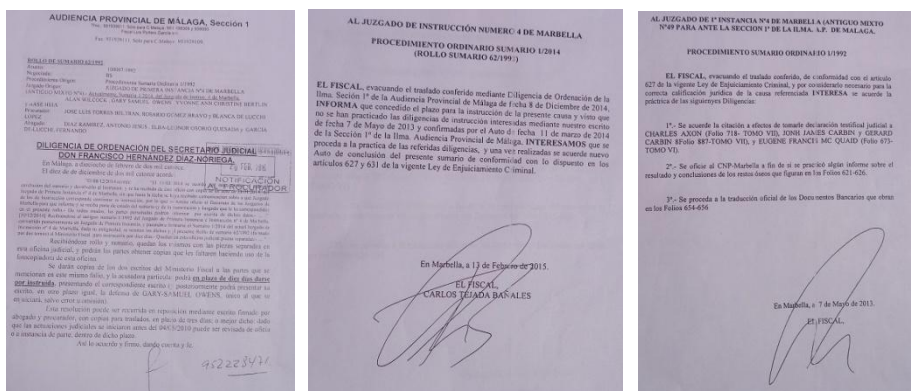

We asked if the lawyer to do several things and she would not do anything, it was shocking but frankly what we have come to expect of the Spanish justice system in andalucia. We ask her to change my bail conditions, and talk to the fiscal about me going to the UK to see my ill mother who is dying of cancer, we asked if she would set up a meeting with the fiscal, we asked for many things but she would do nothing to help, not even contact the fiscal with evidence.

The lawyer from 24 years ago we had is at the same office, Manuel Novella Morales, he came in at the end and did not witness the corruption we saw. But we did not trust him and expressly asked the Marbella court that he would not be our lawyer, so they appointed his partner! We think this is extremely odd and corrupt.

We feel sure that the court are corrupt, we don't trust any person we have met in Spain regarding this case. The lawyer the court appointed us is the partner of the one we had 24 years ago. They keep moving the case from one building to another and from different judges and fiscals, its a game they are playing not a court case. So far the case has been at 4 court houses, 4 judges and 4 fiscals all appear to want to wash their hands of it.

Below are three documents we were given by our court appointed lawyer who we only found we had on the 23 of April, 4 days ago as I write, this is after 6 years waiting in Spain after an urgent extradition that cost millions of Spanish tax payer euros.



There is for sure corruption in this case at several levels, the lawyer the court appointed us is the partner of the one we had 24 years ago. They keep moving the case from one building to another and from different judges and fiscals, its a game they are playing not a court case. So far the case has been at 4 court houses, 4 judges and 4 fiscals all appear to want to wash their hands of it.

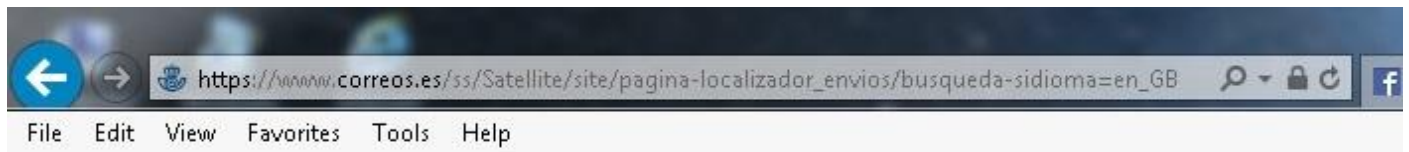

Jayne Owens and I went to see a company of Lawyers recently in Nerja, we spoke to a lawyer called Francisco, he told us prior to the meeting that he as expecting a call that he would have to take in the meeting, we explained to him our current legal position and hat we wanted to do going forward, at the point here I asked him to sign a none disclosure agreement his call came in, they appeared to be talking about me, I heard Francisco say But he has rights, he has a right to do it, then I could not hear the rest, he said he had another meeting, and we should leave the documents and he would read them. We called back a week later and he had not even read the documents, no messages. He asked for another 2 weeks, he was clearly delaying us and had been spoken to prior to our arrival at De Cotta Law. We would like to know who spoke to him and the sequence of events that took place. The mobile phone number must be logged, and the telecoms company can give us the number who rang him in the meeting!

## We Posted 12 Registered Sign For Letters From Spain in Torrox Costa Post Office



This is another instance of perverting the course of justice. As far as we know the 6 Spanish ones all got there, although we have had only one reply from the president of the Poder Judicial via an intermediary (we would like this information verified by the court). Supposedly only one signed for letter in the UK got there, to the Foreign Office, and then later after months we had a vague confirmation that the letter to the prime minister got there, but we have had no reply from any of the 5 people copied in the Foreign Office letter, or from the prime minister.

Here is the denuncia we filed with the Poder Judicial it was done by the Torrox lawyer above for us to try and get something moving, it may need to be revisited, I am sure you are familiar with this procedure. **TSJA 23 Years Ago**

We also filed a case with the TSJA 23 years ago which we still like to pursue, but it was never heard as the judge was gone and I was out of prison by then, the Under Secretary of State for the UK intervened at government level in Madrid over my case, we have all the letters.

Dona Blanca Diaz was tried at the Granada TSJA Court, this was all happening at the same time as I was falsely imprisoned, but the TSJA were not aware of the information we had then.

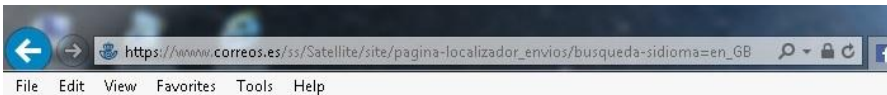
