

## Sample Human Rights Violations & Crimes Log Committed Against Gary Owens:

The attacks described below are only a sample of a few days of the many others that are not logged. This has been the same every day for 6 years. Add to this the effects of Microwave Audio Effect/RFID Implants, hearing someone talking in your head, and other things that are done in conjunction with this, like EEG projection to cause pain over and over. Mason Gang-stalking and much more. To see the many other attacks that are used and support information to their validity please read the **Audencia National Case final.pdf** and all support documents. Bear in mind that many other effects are ongoing, like talking in your head and Directed Energy Weapons stings and other effects, night and day, every day.

Imagine for a moment trying to make love to your partner with someone talking in your head! Some everyday occurrences are, planting images of hammers in my mind and other things trying to get some sort of reaction, they do this as they somehow found out what the murder weapon was in the case that's over.

We need to get forensic psychologist to testify re the continual mentioning of Tor and hammer repartitions via the voice to skull technology, and also showing me false images and saying it's they're look, over and over for years, i want to claim damages for this too. They say we got him over and over when they have nothing, as i was never there. We want to sue individually as well as the organisation involved. They use Memory implantation via subliminal suggestion and precursor thought generation. This is illegal and a way to fabricate evidence and is a class action test case. Plus torture and mental cruelty, and the repetitive nature of bring back traumatic events over and over.

My only thought on this is how can these people have evidence that no one knows outside the court? I have never told anyone any details of the case or shown anyone the court papers. This is a criminal offence in Spain and can only involve a Judge committing a felony act, and carries a mandatory two years imprisonment for disclosure of information in a closed trial. The judge in the case was charged with this exact offence by the TSJA and found guilty. Was it her again?

I have had a high pitched sound in the ear continuously for six years ruining my hearing and music career, pain in my forearms making it imposable to play guitar and piano. They have been stopping me going to the toilet for a poo, by contracting muscles. Doing the same when you wee, slowing it down, to try and show they have some sort of power or control, when it's clear it's an electrical button pressed by a fool. Making you feel like you want to wee when you touch water. Back pain where the heart is to make you think they are something. These are ego trips of the sick minded people that need removing from society, and i consider it my duty to do just that.

When i was trying to send emails to forensic companies to get justice they first cut the internet to stop me, then after that they cut the power over and over in another attempt to pervert the course of justice 13.30, 13/12/2018, 10 emails were sent to forensic companies

These other points are highlighted points of a much greater crime.

13/09/2018 Threat to life sharp electrical pains to left side of head done with increased energy carrier wave in my forehead and temple area with continual verbal threats to my life.

15/11/2018 at 15.04 – Threat to life shocking heart like a needle in your heart clearly electric and a carrier wave.

16/11/2018 at 12.10 – Threat to life shocking heart like a needle in your heart clearly electric and a carrier wave.

17/11/2018 at 12.02 – Threat to life shocking heart like a needle in your heart clearly electric and a carrier wave.

18/11/2018 at 19.23 – Threat to life shocking heart like a needle in your heart clearly electric and a carrier wave.

20/11/2018 at 00.39 – Threat to life shocking heart like a needle in your heart clearly electric and a carrier wave. Also at 14.26 and 22.04.

21/11/2018 at 17.16 – Threat to life shocking heart like a needle in your heart clearly electric and a carrier wave.

Strong cramping of muscles like feeling extreme cold, 23.45 Attempted murder while i was outside.

23/11/2018 at 17.46 – Threat to life shocking heart like a needle in your heart clearly electric and a carrier wave. Also at 18.01 and 22.27. Also 21.09 sneeze and runny nose EEG.

Stopped me from breathing by suppressing nerves using EEG or other methods, this is attempted murder and threat to life. 16.51, 16.53, 17.25, 17.45, 21.30

24/11/2018 at 14.20 – Used Neurophone entrainment on me re projecting hertz at me that educe this state, they use auto suggestion/subliminal suggestion to get you to be angry and say things. The auto suggestion is done at 20 hertz.

They constantly daily use a technique of distracting you with a feeling below the left shoulder as part of a distraction process to auto implant suggestions. 13.41, 14.28, 14.34, 14.57, 15.41, 15.51

Another daily occurrence that's used with the same shoulder distraction technique is making you feel like you want a wee, when you know you don't, they use this when you go near water etc, very narrow minded like all the tactics.

Remotely turned of my phone during a call 14.58.

Used an electrical beam/carrier wave to sting the side of my head using a Neurophone set at 25 volts, i have replicated the exact same sensation. 11.35, 11.38, 11.55, 12.03, 12.13, 12,15, 12.21, 15.37, 15.49. Torture

26/11/2018 at 16.59 – Threat to life shocking heart like a needle in your heart clearly electric and a carrier wave. Also at 18.34, 18.38, 18.39, 23.37

27/11/2018 at 18.14 – Threat to life shocking heart like a needle in your heart clearly electric and a carrier wave. Also at 18.23, 18.45. At 11.00 they tried to make me feel odd and tired to stop me writing to heads of security services.

28/11/2018 at 15.53 – Threat to life shocking heart like a needle in your heart clearly electric and a carrier wave.

13.35 Restricted breathing on the hill outside my home, very dangerous and attempted murder.

2.02 playing with inner ear noise on right ear to distract, while getting you to rock back and forth using Neurophone entrainment with EEG.

30/11/2018 at 01.00. – Threat to life shocking heart like a needle in your heart clearly electric and a carrier wave.

02/12/2018 at 13.13 – Threat to life shocking heart like a needle in your heart clearly electric and a carrier wave.

Attack on hands with EEG muscle strain 14.28 then all day on and off.

**Another sample period focusing on other issues:**

16/10/2018 at 16.40pm - Electric went off

Someone is tampering with our electric power supply, we would like the times and dates here checked with the power company to verify if there was an outage on the line in question, for each event. This carries a mandatory prison sentence.

The reason we know it's being done external is that it does not trip any electric mains switches in the Cortijo, in the six years that we have been here this has never occurred before, on all other power outs the internal electric trip switch goes. In all the cases below each time i turned the switch the power came straight back on.

16/10/2018 at 17.30pm Human Rights Violation and Attempted Murder:

I was subjected to a form of torture where they use electrical demerger delivered on a beam to the right muscle causing it to constrict, this causes the person to not be able to eat and suffer like choking and being sick with constant saliva coming through.

16/10/2018 at 20.14pm Human Rights Violation

They were firing a microwave beam over my ear (cochlea)causing an effect like the noise of someone touching your ear, they do this over and over to distract you and cause confusion, it's another form of torture.

25/10/2018 at 15.15pm - Electric went off twice 10 mins apart.

27/10/2018 at 16.00pm - Electric went off.

31/10/2018 at 13.53 - Electric went off

02/11/2018 at 10.45am and 11.02 - Electric went off.

05/11/2018 at 9.00am to 9.40am and 17.52pm - Electric went off this time at the 9.00am time the mains switch was down here like normal at the night it was not the same, no trip switch.

06/11/2018 at 11.37 - Electric went off while brushing teeth, and at 15.13 - Electric went off 6 times.

07/11/2018 at 13.15 - Electric went off

09/11/2018 at 10.15 – Attacked while ill, high pitched noise causing headache, caused runny nose and sneezing and hurting right forearm torture, signal sent many times to fatigue muscle, most likely EEG, causes severe pain and both the nose and arm EEGs are done regular, every day.

**Another sample period focusing on other issues:**

25/12/2018 Threat to life restricted breathing all day continual threat to life

26/12/2018 Threat to life restricted breathing all day continual threat to life, attempted murder

29/12/2018 at 19.42pm Human Rights Violations, Projected images in my mind's eye while awake, clear provocation and encouragement to kill them.

29/12/2018 at 19.42pm Human Rights Violations, DEW attacks on the Heart Threat to life.

30/12/2018 at 18.41pm Moving my eyes forcefully causing instant migraine headache and sever pain and damage to my eyes. Human Rights Violations, Sexual attacks on genitals, attacks on my hands 11.16am and 4.39pm also earlier before i got out of bed, clear provocation and encouragement to kill them in self defence.

DEW attacks on the Heart Threat to life 18.02pm

Threat to life restricted breathing 4.30pm, 4.42pm, 4.54, 6.09, 18.33, 18.41, 19.40, 22.20 continual threat to life, clear provocation and encouragement to kill them in self defence.

5.55 attacked hands and left leg tendon that's an old injury and very painful, clear deliberate torture and warrants a response to attack and kill them.

31/12/2018 at 14.43pm and 20.50pm, 23.46 pm DEW attacks on the Heart Threat to life Human Rights Violation.

31/12/2018 at 3.03pm Human Rights Violations, Sexual attacks on genitals, attacks on my hands, RNM and Projected images in my mind's eye, clear provocation and encouragement to kill them.

Threat to life restricted breathing 17.48pm and at 20.50pm continual threat to life

3.10pm Attack on finger joints with EEG projections using Neurophone

01/01/2019 at 9.38 am Human Rights Violation threats to life and RNM all night

Threat to life restricted breathing 12.28pm am 12.32am 12.39am 16.11am and at 20.50pm continual threat to life

10.10 am, 10.17am, 11.25am, 11.40am, 11.52am, 12.06am, 12.12am, 12.14am 15.07am 16.59pm DEW attacks on the Heart Threat to life.

03/01/2019 Woke up 5am they were suggesting i killed the guy in the Spanish case and were trying to nod my head using EEG projection when it was proven i was not there, showing these people cannot be National Security and proving they are a threat to my life and warranting an all out response to kill them in self defence at any cost.

They then attacked my hands that have for sure ended my music career; just so we are clear they will die for that alone.

They attacked heart with DEW, at 5.30am 11.09pm sexual attacks and torture on my genitals.

20.00pm Choked me like many times before, causing me to regurgitate food and a lot of pain, i had not eaten for days and had to go to bed i was so weak. I will move against them in the next few days to kill all of them at any cost.

04/01/2019 Image projections RNM (Remote Neural Monitoring), sleep deprivation as has been going on for years. Threat to life DEW on heart, attacking of the hands.

15.50 Threat to life sharp electrical pains done with increased energy carrier wave in my forehead and temple area with continual verbal threats to my life.

06/01/2019 Morning made me sick firing microwaves at my stomach over and over causing gas expansion and pain as well as having to be sick over and over. 15.07 Threat to life DEW attack on heart. Low pitch vibrating this is microwave and accompanied by high pitched noise in the ear that has been going on for six years now.

I am going to kill these people in self defence at any cost. Tried Lawyers , Justice system and police no one will act so i will.

**Another sample period focusing on other issues:**

21/01/2019 All night and day Dream projections, threat to life heart DEW/EEG stings, restricted breathing, torture, sexual attacks, EEG projections using a Neurophone stressing tendons in right and left leg, DEW in eyes causing headache and pains.

22/01/2019 All day restricted breathing on and off threat to life, heart stings threat ti life, pain to hands to stop me playing guitar.

23/01/2019 Went to bed 3pm, woke up shaking violently with repeated EEG projections, and sever head ache, restricted breathing all day on and off, 9.43 am threat to life heart sting using DEW.

24/01/2019 Over use of the word Mark for days without them being able to stay awake, pre cursor thought and subliminal word implants, pain under left shoulder same as reported before.

25/01/2019 4.30am sexual attacks, restricted breathing threat to life 16.35pm, attacks with DEW on the side of the head 21.30pm, 10.44 verbal admission of torture, threat to life DEW heart sting 22.13, 22.41, 23.42,

26/01/2019 Sever pain in the throat EEG projection tightening of throat stopping me singing, 10.30am, 14.09, pain in arm and finger joints stopping my music career 10.37am, tentacles sever attack DEW 22.42, restricted breathing threat to life, severe pain in stomach not on the surface, pain in hands, pain in right thigh joint over and over in early morning torture, burning heal with carrier wave.

27/01/2019 Pain in left big toe joint EEG or MAE beam, 00.42am, sever pain left eye 7.12am carrier wave DEW, 7.15am pain in stomach when urinating, caused by trying to restrict the bladder using a carrier wave, Pain in side of left head over and over for one hour 8.50 am, 9.35am, pain in arm 8.54, 9.34am.

Throat tightening painful 15.02pm, continually using EEG carrier wave to make sensations in my fingers ruining my muscle tone to play guitar and trying to draw a reaction a pure provocation and justification to kill them in self defence. Pain in right eye 18.09, 21.15, then left eye 20.12. Saying he did it over and over for same reason to provoke a reaction and response 18.10. De focusing eyes with loud whistling in my left ear 18.13. Pain in left heal 21.15, 21.18. Urge to pee controlling bowl movements and urinating is one of sick minded things they do. Right leg tendon over stressing using EEG over and over same as what put me in hospital 18.28. Severe pain left heal 19.19, 19.57, 20.57, this goes on all the time like other effects described earlier in the opening statement. Constant distraction so they can use subliminal messaging and implanted thoughts, to make you look in a direction or nod so they can then say yeh he did it as in earlier statements. Pain in thumb joint and fingers meaning i can't play guitar any more or piano, and provoking me. Left thigh joint pain 20.44, right inner ear DEW/carrier wave/implant 22.07. Right arm pain 22.14

26/01/2019 Threat to life 00.35 heart DEW sting, pain in the right eye 00.51 dew. Pain in left ankle 00.51 DEW, pain in left eye 00.54, 00.57. Threat to life restricted breathing 1.12.

04/02/2019 Woke up shaking violently, after i was awake it happened twice again, dream projection, same as previous days. Threat to life 19.31 19.39 over and over on heart DEW sting, pain in the left eye 19.30, 20.21, 21.06, 21.20, 22.22 dew, high pitched ringing in the RFID implant 19.36, 21.37, pain in head at back from DEW/MAE carrier wave. Hitting the back of my head with a carrier wave with gain turned up 25 watts deliberately causing a headache same as they did last night, and have done many times before. Pain in my left forefinger, on the joint caused by them using nerve stimulation with electrical current from a carrier wave. Getting me to point my finger by nerve induction, and saying gun, this has been going on for years and now i can't play guitar because of coordination, I'm going to kill them for this alone. Sexual attack on my penis, using microwave laser type beam/DEW. I have noticed many times that when i am watching TV on the computer, the ambient sound of the Voice to skull is embedded in the sound coming from the computer, so when i pause suddenly all the V2k stops, this suggests that the RFID implant is linked to a network. They are previewing what i see, and have a way to move

things on my screen while I'm viewing it, this suggests that they are on the same network, and or using software that allows someone else on your pc like when you hire a tech guy from distance to look at your pc problem. Pain in left fingers DEW 22.21, 22.39. Pain in right forearm as reported many time in the past over and over stopping my music career. Pain in left heal like a electric shock but on low voltage 23.03, this is a common daily occurrence and has damaged my feet and caused many blisters under the skin.

What happened on the 04/02/2019 the exact same things have been happening every day for over a week, and this is torture and warrants a life sentence for all under UK, EU and International law.
