I would like to thank you for your update on the case, received 29th May 2018.

This letter appears to be a total lie, one of you is not telling the truth, Malaga Audencia Provincial Court 1a Or you!? So our only option is to file charges against you, Malaga Audencia Provincial Court 1a and Marbella courts so that we can find out who that is. It's clearly a Judicial Mafia, and a disgrace that you have done nothing but lie for a whole year, its a legal right to have the court papers so we have no alternative than to press charges it can only be corruption which we will be taking to the EU, shame on you.

Here is why:

In relation to the administrative procedure of patrimonial responsibility of the state (Number 311/2017) promoted by Mr. Samuel Gary Owens, as a result of abnormal operation of the administration of justice, I inform you that, for the purposes of the instruction of the reference file, has requested to provincial hearing of malaga - section 1a, the remission Number 62/92 (summary number 1/1992 of the inscription court number 4 of Marbella), in which motivates its economic claim

This is part of a letter we received from the Foreign and commonwealth office of the UK FCO Foreign and Commonwealth Office UK Embassy.

Whilst we sympathise with your situation, the British Consulate staff are not legally trained or in fact have a legal section that could advise or intervene in these matters; nor is it our role. We are unable to become involved in specific cases or investigate particular cases. However, I can now confirm that in this instance, we have been able to speak with Malaga Audiencia Provincial courthouse, "Seccion 1ª" who are the courthouse mentioned in the paperwork you sent us, that the Spanish Ministry of Justice requested apply for the necessary information from Marbella Instruction court Nº 4 in relation to Mr Owens's case. In spite of data protection, the Malaga Audiencia Provincial court did agree to check on the progress of this matter. The Audiencia Provincial de Malaga, Seccion 1ª Court whilst unable to discuss the specifics of the case told us that to date they have not received a request from the Spanish Ministry of Justice, consequently they have not requested any papers from Marbella.

If it is not you lying, i want Malaga court arrested forthwith and charged with conspiracy to pervert the course of justice and criminal negligence, and because they are in a Judicial Mafia we can seize there assets as part of compensation and court costs. I have asked my lawyer to bring criminal charges against all of you pending the truth. I am waiting to hear from him now, he has also told me openly that he knows it's the Judicial Mafia causing this and he does not like it and wants YOU to use this case to stop the Judicial Mafia for good. That's why we want a national

investigation in the Audencia National with every person involved suspended from duty pending trial.

The point is that we are being deliberately denied justice, and this is also a criminal offence. We cannot get legal advice without the papers to sue you forever in the EU for hundreds of millions of pounds.

I have been tortured by your security services and the UK NCA all Mason related, and i will be having a local police officer they used arrested by a judge in Torrox Pueblo, Malaga for conspiracy to pervert the course of justice, torture and illegal surveillance. I would of reported this to the local chief of police but my landlord a local prominent figure told me that he's on the run for arms dealing and has stolen arms from the police. Your country is a disgrace. I have listed the miscarriages of justice already submitted to you and asked for protection and you have not even responded, we are filing a criminal negligence charge just for this also.

There are many things that we need to discuss re the case, i have a huge amount of information that proves Torture, Gang Stalking, Attempted Murder plus many other crimes outlined all evidentially based. They use Directed Energy Weapons and Microwave Auditory Effect on me along with EEG projections recorded on Neurophones and sent by mobile telephones along with other surveillance tech. All to cover up crimes they are committing and have committed as outlined in my brief for the Audencia National Prosecutor. (Documents attached)

What is going on here is a clear cover up at all levels; you have to stop standing with the wrong people before you can't!

You need to pay me compensation which is nowhere near enough whatever it is.

You need to bring charges against the UK authorities for driving this agenda of the Masons to cover up the theft of my £2 Billion pounds in IPR (Intellectual Property Rights) in the UK, this is the motive for all their actions to cover up corrupt Security Services and Masons, if you stand with them, you will fall.

You have to use this case NOW, to bring the judicial mafia under full control and phase them all out of the system, it's clearly corrupt from the top to the bottom.

As a person who has been through the system what would you think if the paragraph below occurred in your case?

"The judge in my case is arrested imprisoned and found guilty of charges, the same type of charges i have against her, and want to progress both criminally and civilly. The judge tells the newspapers that if she is imprisoned she will talk all about the Judicial Mafia and accuses the president of the Poder Judicial of being the head of the Judicial Mafia. The next thing that happens is the judges charges are dropped and she becomes a judge in a different part of Spain.

The point is, that if my case against the judge would have gone to the TSJA 28 years ago like it was supposed to, she would be in prison and not be a judge and i would have all her money. That's still going to happen or we are going to have a very big problem in Spain.

In simple terms so it's not confusing to you, i want as a legal right the court papers from the case, to withhold them is conspiracy too pervert the course of justice, and i wish to press charges already against Malaga and Marbella courts. While you hold the documents, you are withholding

my legal right to press criminal charges against you, and the rest of your Judicial Mafia, and of course sue everyone involved civilly for hundreds of millions in damages.

Every document i want, so i can sue your justice system for 20 years costing you hundreds of millions in costs.

In the initial submissions and requests to the court i asked for medical assistance to remove an RFID Implant the dentist in Fuengirola put in me, i saw him do it, but did not know about the technology at the time. I have attached the denuncia regarding this. We will be filing this as a legal case in the next week in Malaga. I want this removed immediately. Along with a full account of who is responsible for every decision from beginning to end, and i kid you not, if you don't do this up you will be finished in the justice system. IT WONT BE GOING AWAY
Next it will be right in your corrupt faces in Madrid, at your doorstep.

I also want a hair follicle test done for Microwave Radiation exposure due to the attacks and torture that has been done to me.

I have made multiple requests for protection to lawyers and courts it is a criminal offence not to see to this request and i want all the legal people involved removed from duty pending an investigation and all their assets embargoed pending outcome of trials, by the ministry.

I want to know who is doing the RNM, DEW, Voice to Skull, we are filing legal charges of torture and that carries a life sentence, i want this sentence imposed to the full.

The list of miscarriages of justice in this case are astonishing, and the very fact that you have not come forward and apologised for your countries disgraceful conduct is also astonishing. Corruption like your judicial mafia belongs in a third world country which sadly is what Spain is mentally!

Attached in the Audencia National case documents are charges i want to bring including attempted murder, conspiracy to pervert the course of justice and many other charges that involve a life sentence for those responsible. If you don't act on it, and do your real duty outside your corrupt Judicial Mafia i will be forced to fight and i will bring you down at any cost, and i will bring it to your front door.

You should stand by me and go in the press ask these questions below, questions i have been stopped from asking by the your corrupt security services, who are stopping the stories going to the press and its all Mason related:

These are some of the points i wish to discuss with the Spanish media, questions that if you were legitimate justice system you would want the answers to:

Spanish Press Release:

I want to know how the Spanish justice system can destroy my life, breaking its own laws with its legal representatives committing crimes to falsely imprison me and then destroy my life? If it were not for the fact that I was a public figure in the Heavy Rock business they would of got away with setting me up!

When i was arrested and first appeared in Marbella court in front of Dona Blanca, she had a court functionary measure my feet, in open court, in front of everybody, she had all the carpets from the crime scene and there was footprints everywhere from the people that did the crime, i have size 40 or size 6 shoes, the people that committed the crime had much larger feet, she said in

open court right then that i was not there and could not of been involved, i want anyone from that hearing to come forward including my interpreter!

I call for the police officer from the Aresto Municipal Marbella who told me that judge Dona Blanca Esther Diaz and her husband police inspector Jimanez who was the chief investigating officer for the Marbella International Crime Squad, part of Interpol, (a miscarriage of justice in itself that they were married), were planning to set me up for the crimes and he did not agree or like it, to come forward and speak the truth of what he knows, and explain in his own words why he let me escape from the Aresto Municipal in Marbella because he said they were setting me up. I ask this person to come forward for justice sake and expose this corrupt judge and her bent police husband, Spain deserves better.

I call for the Marbella Court number 4 functionary who was also imprisoned by the judge Dona Blanca to come forward and talk of how he knew the documents in my case were falsified by Dona Blanca and Inspector Jimanez, and what else does he know about the goings on regarding this corrupt Judge and Senior Police official!

How can Dona Blanca be a Judge in Spain when we have proof she is a criminal? Who is covering this up? I call for her immediate dismissal from the justice system and her assets seized as compensation for what her and her husband have done to me. I would also call for all the justice system to be scrapped as its not fit for purpose clearly.

I call on the NCIS (National Criminal Intelligence Service)/MI6 Agent and Norwegian Intelligence Agent who met me upon my release to come forward and explain where they got the information from that the person murdered was in fact a Norwegian Drug Trafficker, who was buying cocaine on the costa del sol and selling it through his own night clubs in Norway.

I openly accuse the British Drug Mafia, the same British Drug Mafia that the British government don't want to admit exists, the same British Drug Mafia that uses Freemason lodges in Spain to coordinate and run drugs gangs. I call for all decent people to stand up with me and destroy them and the perversion and corruption that surrounds them.

All British Freemasons should be outlawed in Spain as they have been in the recent past, where i live they humg Masons less than 50 years ago just for being Masons, maybe this could be re instated, they are sucking the life blood out of the economy of Spain. I appeal to the catholic church, I point out the Masons are in fact running the British drugs Mafia and are the same people that stole my Intellectual Property Right that led to the false extradition, and the same people who killed the person in my case.

The British Drug Mafia and Masons are strangling the life out of Spain and have been doing for decades, I think the Spanish people should be aware of what's going on in their own country. 25 years ago when this started I saw Spanish people selling Maracas and bulls from bull fights on the beaches, today the Nigerian Mafia have 15,000 people selling false goods up and down the coast taking 15,000 Spanish jobs and raping the Spanish economy of all the tax these people should pay as well as denying Spanish citizens the right to work, and why? So bent police official can line their pockets in backhanders to let them do it. Spain needs to wake up! Just exactly how many of these 15,000 people are radical Islamic? It's an incredibly delicate situation supported by a corrupt system endangering everyone in Spain except the people stealing the Spanish workers money, shame on you all for what has happened to me and shame on you all for not acting when your country is being colonised by criminals.

I Call for the ceasing of the British Drug Mafia and Freemason assets as compensation to me and others under RICO law or EU equivalent (as they are clearly organised crime) who have had their

lives ruined by these illegal operations, taking countless jobs away from the Spanish communities and also call for all illegal goods being sold by "Lucky Lucky Men (Nigerian Mafia)", who could be from Boca Haram for all we know! To be removed from Spain.

I call for a public enquiry into how Spain can waste millions of Euros of tax payers money on a false extradition, and spend 25 years destroying our lives for a case that there is zero evidence for, in fact it was the opposite there is 100% proof I was not there, that was dreamt up from the start by corrupt members of the Spanish justice system. I have had no legal representation at any point, I have had my human rights violated in 34 out of 36 European human rights laws, as per Section 6 of the Human rights act and all others. The Spanish and European Justice system has failed at every level, it's a total disgrace and not fit for purpose. I want compensating and I want some justice! I demand a full review of funding for the justice system and security services that has clearly been abused in my case and for corrupt reasons!

The Spanish ministry should take out a joint prosecution with me of the UK security services manipulation of this case, all Mason related. For Conspiracy to pervert the course of Justice. That way the Spanish tax payers can get back the money they got duped into paying out by corrupt Mason security services.

You should also seize all Masons and Drug Mafia assets, villas/property, bank accounts, Businesses etc, to pay me and other compensation for your lapse in judgement and clear criminal negligence.

This would bring 100 Billion into the Spanish coffers and remove the plague of corruption. If you don't do it, and i don't hear soon as in days not weeks, i will be forced to take the law into my hands as you no longer have the right to represent the law and sit in judgment, and i will destroy everyone in Spain involved including the Judicial Mafia at any cost, you have been warned.

Attached with this letter are many documents and proofs, i have all the evidence, i want the court to pay my compensation to avoid an open public clash. I demand that you put everyone involved on trial as outlined in my Audencia National Case attached.

I will be going to a local judge and police commander to press these charges outlined in the Audencia National Case i have filled with you forthwith.

In the absence of any quick response days not weeks, i will be providing the Spanish people with a display of what happens when corrupt people pick on the wrong person. It will be relentless and sustained and it will cause the Spanish people to wake up to the stink of corruption in your country, if you want to go that route, i am ready to go now.

In the absence of Justice and law and order and with corruption abound, there is only one course of action, all out war on the Spanish judicial system and corrupt security services.

Separate to this i have to turned down musical commitments that would make me millions of pounds, i am published by Sony Artist Management the largest publisher in the world, and my record is on current release, i will be filing a lawsuit for damages relating to this issue separate from the current case most likely attached to the criminal negligence charges we are bringing and Torture charges that we expect all to get life in prison for. Or we will file in the EU against the state of Spain and UK.

There is no one either in the Spanish authorities or UK Authorities that we can or would trust due to the freemason and Judicial Mafias manipulation of the whole case and system. They have made fools out of the Spanish Justice system.

If you don't stand by me and sue them you are acting against your own country and that would make you a traitor. You have this one and only chance to act NOW, OR I WILL!
